**CORRIGENDUM**

In order to remove practical difficulties and to bring the procurement process in conformity with actual market availability and the requirements of fair competition, which is fully permissible under Rule 40 of the Khyber Pakhtunkhwa Public Procurement Rules, 2014, and in pursuance of the terms & conditions contained in Para (a) & (b) under the heading "Amendment of Bidding Documents" at Page No. 06 of the Bidding Documents, and in continuation of this office Tender Notice regarding procurement of goods under Rule 6(2)(a) of the Khyber Pakhtunkhwa Public Procurement Rules, 2014 through Single Stage One Envelope Procedure, published in Daily Mashriq and Daily Dawn dated 13-05-2026 and subsequently uploaded/published on the Procuring Entity Website, E-PADS and KPPRA Website on 13-05-2026, it is hereby notified for the information of all concerned/bidders that the item namely "Internet Connection 30 MB (Shared)" appearing in both Lot-A (Procurement of Virtual Court Equipment) and Lot-B (Procurement of Virtual Access Point Equipment) is hereby withdrawn/deleted from the scope of procurement.

The said item has been deleted on the ground that shared internet/data facility is presently not available in District Lakki Marwat and its procurement through any prospective bidder is practically not feasible. Consequently, inclusion of the said item is likely to create unnecessary complications and may adversely affect fair competition amongst the participating bidders. Furthermore, this office is already equipped with optical fiber-based internet/data connectivity, which shall be utilized for operation and functionality of the proposed Virtual Court and Virtual Access Point facilities.

Accordingly, all prospective bidders are directed not to quote any rate against the aforesaid item while submitting their bids for Lot-A and Lot-B. All other specifications, terms & conditions contained in the original Tender Notice and Bidding Documents shall remain unchanged and shall continue to be valid, operative and binding upon all concerned.
